- Natural Resources Conservation Service Ms. Karen Woodrich updated the board about these items:
  - o RCPP is in its third funding cycle, with 5 projects approved this year. One being for Knox County Conservation District. This program uses a separate pot of EQIP funds.
  - Conservation Planning and Contracting continue to be priority for field offices.
  - o NRCS State Conservationists recently met in Oklahoma for a Vision and Strategic Planning Session.
  - o Hiring Freeze released to hire 150 people nationwide. Kentucky will have the opportunity to hire 3. Hiring will be based on workload analysis, with the goal of making the federal workforce smaller.
  - o There is currently not a clear direction of the National Office until a new Chief is announced.

- Farm Service Agency Not attended
- Energy and Environment Cabinet Not attended.
- University of Kentucky Not attended.
- Kentucky Department of Agriculture Brent Burchett forwarded a report.
  - o Commissioner Quarles continues to work on budget and other legislative issues at the State Capitol.
  - KDA was proud to staff the Kentucky Farm Bureau Beef Expo on March 2-4 The Expo recorded sales of just over \$1 million, crossing seven figures for the seventh consecutive year in its 32nd edition at the Kentucky Exposition Center.
  - The Commissioner's fight against hunger continued in recent weeks, with his "Serving Up Solutions" dinner with US Ambassador Kelly Craft and Kentucky Chamber of Commerce Board Chair Joe Craft raising \$39,000 for two anti-hunger local organizations.
  - o KDA has been using his social media platform to encourage farmers to apply for the Leopold Conservation Award, due April 15.

- **KACDE** Kayleigh Evans updated the board about these items:
  - o Board is interested in the breakout sessions.
  - o Benefits of the Share Fair.
  - o Could have new employee training at the convention.

  - o KACDE will work on updating the list of Supervisors Years of Service statewide.
